How to Pass the Baby Bar: The Baby Bar (California First-Year Law Students' Examination or FYLSE) is a one-day exam, during which students must complete four one-hour essays and 100 multiple-choice questions in Contracts, Criminal Law and Torts. Examinees must score at least 560 points out of a possible 800 points to pass the exam. this is the equivalent of answering 70% of the questions correctly.
