The scores of the exam sections are weighted as follows: MPT 20%, MEE 30%, and MBE 50%. West Virginia makes bar exam results available approximately two months after the exam.

West Virginia adopted the Uniform Bar Exam (UBE) in May 2016 and will administer the UBE beginning with the July 2017 exam. You need a minimum scaled score of 270 (out of a possible 400 points) to pass the exam. This is a higher passing score than many other UBE jurisdictions, so you have to take the exam seriously.

In 2016, the Virginia Board of Bar Examiners considered the UBE, but stated that "it is not in the best interests of the public of Virginia or the Virginia judicial system." [25] In December 2018, the Indiana Supreme Court created a commission to review the future of the state bar examination. [26]
