Procedure for change in bank account signatory of a company

To change the signatories on your Co-operative Bank business account just follow these four easy steps: Complete all relevant sections in the form and write clearly in CAPITAL LETTERS. Ensure all signatories have read the 'Important information' section in the form and sign as appropriate.
