The Law provides a framework for practice which grants the social worker with powers to take appropriate action. A starting point for understanding the legal framework is Statute law which is one of the main sources of law and is contained in an Act of Parliament. The Children Act 1989 is an example of statute law.

The Law and Social Work Practice

Because the social worker's agency received federal funding for several of its programs and the social worker had referred the client for substance abuse treatment, the social worker was obligated to comply with a very strict federal regulation (Confidentiality of Alcohol and Drug Abuse Patient Records, 42 CFR Part 2) that includes explicit guidelines regarding disclosure of confidential information by agency staffers to law enforcement officials without client consent.
