The prevention of legal malpractice requires time, discipline, attention to detail and a willingness to fully implement specific office procedures designed to prevent claims. Policies for docketing and conflicts checks should be used in every situation. First, use a centralized docketing system.

A final area of legal malpractice litigation concerns claims that do not involve a deficiency in the quality of the lawyer's legal services provided to the client, but an injury caused to a third party because of the lawyer's representation.
