The purpose of the Payment Error Rate Measurement (PERM) program is to measure and report a national payment improper payment rate for Medicaid and the Children's Health Insurance Program (CHIP) to comply with the requirements of the Improper Payments Elimination and Recovery Improvement Act (IPERIA) (2012).

### Payment Error Rate Measurement Manual - CMS

The PERM program measures improper payments in Medicaid and CHIP and produces error rates for each program. The error rates are based on reviews of the fee-for-service (FFS), managed care, and eligibility components of Medicaid and CHIP in the fiscal year (FY) under review.

PERM certified expired means that PERM was approved but was not used within 6 months to file i140 with USCIS. This PERM has expired and a new PERM should be filed to get a new Green card priority date.
