Go to Manage > Purge Unused. Go to the Application Menu > Save As dialog box, and save the file under a new name (in ...

Options to recover might be needed if a model was deleted or if a previous version needs to be used. There are a few ways to recover models stored on BIM 360. Restore previously saved versions - For corrupt models that cannot be opened, follow the article Downloading previous copies of Revit cloud

### Recovery options for Revit cloud workshared models stored ...

Start Revit. Click Collaborate tab Synchronize panel (Restore Backup). In the Browse for Folder dialog, navigate to the copy of the backup folder for the central model (created in step 2), and click Open. If a dialog displays the message "Can't find project file <file\_name>. Do you want to attempt recovery?," click Yes.

Manually Recover Revit File A corrupt element may be able to exist within the project without leading to errors so long Error: "Data in file (filename).rvt is corrupt and needs to be manually.

### Manually Recover Revit File

In many cases when Revit crashes (Fatal Error/Serious Error) you will be prompted to save a recovery file. If you have this option and chose to save the recovery file, then changes which were not previously saved will be saved in the recovery file. However, in some cases a crash is so severe that Revit is not able to save a recovery file.

The next step is to start Revit by double-clicking on the icon (not the file). Then, using the Open command, browse to your recovery file and highlight it (not double-click). Click on the Audit option at the bottom of the dialog, click OK on the notice that appears, and click on the Open button.

### Revit Recovery Files - RVIT

How to properly recover a central file in Revit. To properly recover a Revit file you will need to do the following: Copy the backup folder to a location without the central file (this step is critical to prevent the corruption in the project from stopping the recovery). Start Revit. Open the software>from the ribbon go to the Collaborate tab>then to Restore Backup.
