Landlords can issue an unconditional quit notice. Tenants must claim any abandoned property within 30 days. You cannot discriminate and refuse to rent to victims of domestic violence. If you rent out a residential property to tenants, it's your legal responsibility to ensure that the facilities are " habitable " by maintaining the common areas and the plumbing, making sure the heat works in the winter, fixing appliances, and keeping the rental property structurally sound. While heating and plumbing problems should be addressed within 24 hours, less-immediate repairs should be handled within 48 hours.
