This may award your current spouse, former spouse, or dependents, a specified dollar amount.

The TSP will need a Retirement Benefits Court Order after the divorce. This can come from the divorce decree, legal separation or annulment or it can come from the court-approved property settlement agreement. The Qualified Domestic Relations Order may also serve as the RBCO.
